

# **Key Information Document**

#### **Leave Entitlement:**

35 days per year (pro-rata). Payment for this accumulates at a rate of £1.70 per hour. Once AWR qualified the leave entitlement will be 35 days per year (pro-rata) with payment accumulating at £1.70 per hour.

#### Deductions from your pay required by law:

Income tax: Calculated at a rate of 20% of wages above the monthly limit of £1,048 and at 40% above the monthly limit of £4,189.

NI: Calculated at a rate of 12% of wages above the monthly limit of £1,048 and at the rate of 3.25% above the monthly limit of £4,189.

Student loan (if applicable): Student loan rates and thresholds depend on the Student Loan Plan you are under. For Student Loan Plan 1 it is calculated at 9% for wages above the monthly limit of £1,682.91 Please be aware that with all of these statutory deductions exact rates can vary depending on individual circumstances.



## Any other deductions:

Temporary workers who are eligible for a pension and have not opted out will contribute 5% of earnings above the £520 threshold.
