#### **Leave Entitlement:**

28 days per year (pro-rata). Payment for this accumulates at a rate of £1.45 per hour. Once AWR qualified the leave entitlement will be 40 days per year (pro-rata) with payment for this accumulating at £2.18 per hour.

### Deductions from your pay required by law:

Income tax: Calculated at a rate of 20% of wages above the monthly limit of £1,048 and at 40% above the monthly limit of £4,189.

NI: Calculated at a rate of 12% of wages above the monthly limit of £1,048 and at 2% above the monthly limit of £4,189.

Student loan (if applicable): Student loan rates and thresholds depend on the Student Loan Plan you are under. For Student Loan Plan 1 it is calculated at 9% for wages above the monthly limit of £2,082.50. Please be aware that with all of these statutory deductions exact rates can vary depending on individual circumstances.



### Any other deductions:

Temporary workers who are eligible for a pension and have not opted out will contribute 5% of earnings above the £520 threshold. Eligible temporary workers will be contacted separately with further details.

# **Representative Example**
